ECW's Multi-year Resilience Window (Purpose)

ECW's flagship funding modality (focus: protracted crisis countries). A call from the WHS, it's about:

- Fostering joint planning and programming in crisis and emergencies to ensure a bigger impact, building on complementarities and partners' added values.
- Bringing together partners to leverage on resources and in-country expertise (ECW serves as a catalyst).
- Strengthening the nexus between humanitarian and development efforts.

SOP Phase I: Prior to mission fielding

- ECW selects country, based on ExCom selected countries and set criteria for protracted crisis.
- Familiarize with HRP, UNDAF, National Development Plans and Strategies, and draw links to ECW goals.
- ECW contacts RC/HC as main entry point to ensure convening power with all partners.
- Organize mission agenda with relevant UN agency.
- Share the mission agenda with ExCom members.
- Ensure ECW's information kit availability

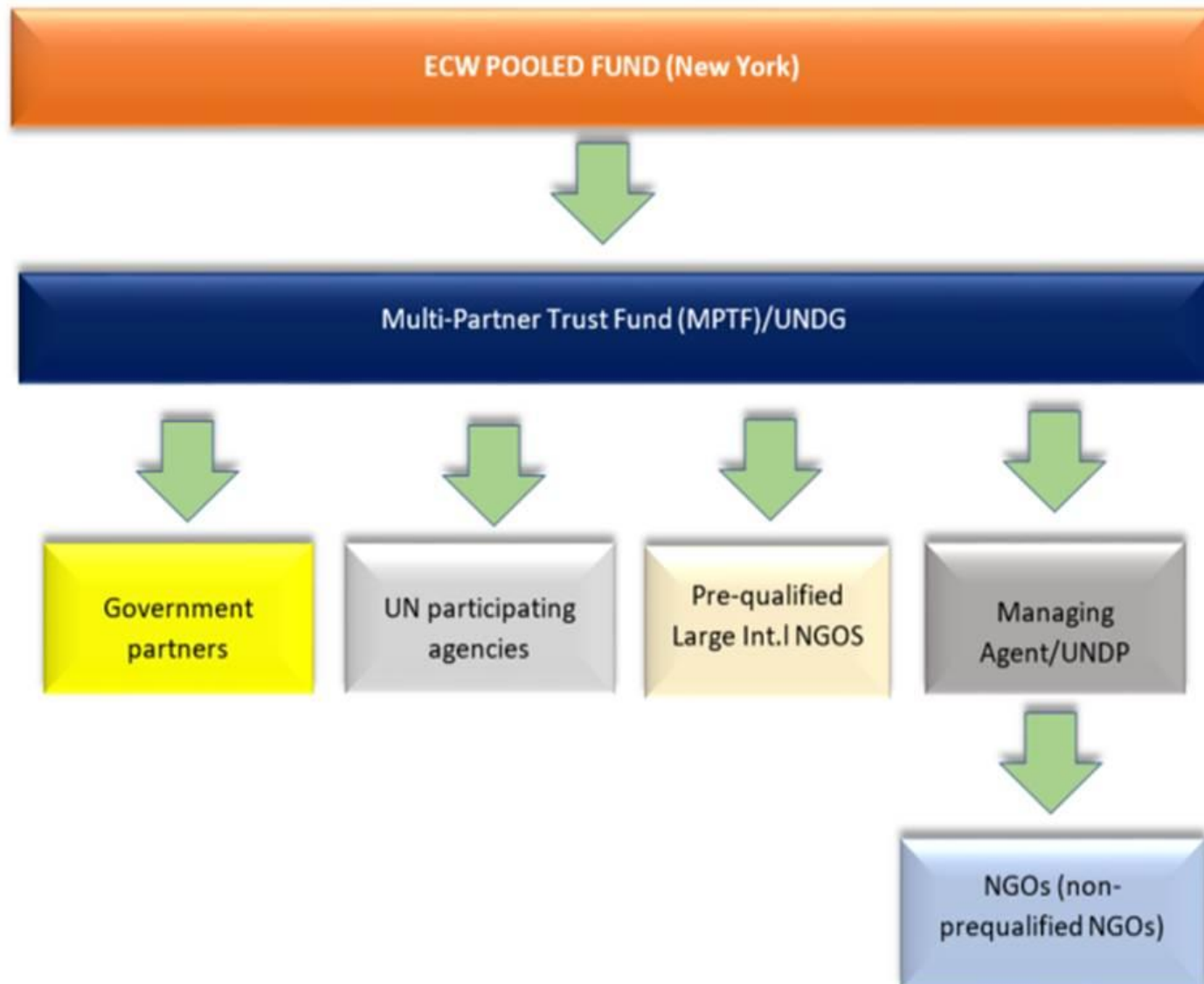
SOP Phase II: During the Mission (1 week)

- Briefing with the RC-HC.
- Meetings with all relevant partners (govt., cluster, LEG, UNCT, NGOs- Nat.& Int.l, and donors, in particular, ExCom members representatives in-country).
- Gather consensus on who is best positioned to lead the joint planning and programming process for the MYP.
- Identify the focus areas for the MY programme.
- Visit education facilities and beneficiaries and interview/consult stakeholders and beneficiaries.

SOP Phase III: After the Mission

- Share mission report with in-country lead agencies and ExCom.
- Ensure remote assistance: technical support and backstopping to the country elaboration team.
- Lead agency to develop proposal (in 8 -12 weeks) and submit to ECW.
- ECW Secretariat to ensure technical review and quality assurance of proposal.
- Submission of MY proposal to ExCom for review and approval.
- Approve the MY Proposal and ensure speedy disbursement of funds.
- Follow up, monitor, report, steer and evaluate.
