

### ECW Resource Mobilization Efforts

Please find below some bullet points to update on ECW RM efforts:

- As of end of April, ECW mobilized a total of 344.1 USD of which 10.4 are pledges pending signing.
- ECW Released its Case for Investment calling on governments, private sector companies and foundations, philanthropic organizations and global leaders to support its efforts to mobilize USD 1.8 billion in funding for education in crisis by 2021 – to support the delivery of quality education to nearly to 9 million children.
- This replenishment effort includes USD 673 million for the Education Cannot Wait Global Trust Fund, which supports rapid emergency responses, capacity building, global goods, and most importantly, seed-funding investments for the MYPRs.
- ECW fund raising efforts are focused now on reaching its USD 673 Million target as its priority. By providing seed funding to MYRPs and FERs, ECW seeks to catalyze an additional \$1.2 billion in co-financing at the country level.
- ECW will release its digital campaign during the month of June to present partners with a platform to access information on the Case for Investment, monitor replenishment work, and also interact with partners advocating on behalf of ECW.
- ECW HLSG approved an ECW replenished event: A high-level event on Education in Emergencies & Protracted Crisis to take place during the 2019 UNGA week, scheduled for Wednesday 25 September. The main goals for this event are; 1) Showcase the plans and accomplishments of ECW to date; 2) advocate for more support to EiE and protracted crises; 3) promote more investment to scale up good practice and innovation for delivering quality education in crisis; 4) to provide donors with an opportunity to announce new financial commitments in support of ECW (**Annex A**).
- In preparation for this event, the ECW secretariat with help of ExCom Civil Society Representatives and a core group of civil society partners (Save, Plan, Global Citizen, and TheirWorld) are working closely to mobilize the support of civil society groups, coalitions, and EiE advocates to make the case for investing in ECW at donor country level. More specifically, to lead a dialogue with governments, private sector foundations, and other donors to determine realistic and mutually supported financial asks towards the UNGA replenishment event and beyond.
- The recently launched ask for ECW by CSOs in the UK for £75 million, following consultations with DFID reach a mutually acceptable ask presents a successful model to follow in other countries.
- Another successful effort was the inclusion of a funding ask for ECW in the 2020 *STATE, FOREIGN OPERATIONS, AND RELATED PROGRAMS APPROPRIATIONS BILL*, which was released on May 15.
- ECW and the core group of CSOs supporting its replenishment efforts are now coordinating with the different coalitions and groups to organize a wider RM effort to ECW in Europe, USA, Japan, the Arab Gulf, and beyond.
- On RM efforts from private sector foundations, ECW is currently in dialogue with a group of partners in USA and Denmark with strong encouragement and support from the two governments. We are hoping that at least two of these foundations will be able to commit additional resources for ECW investments during the 2019 UNGA event.
- Items for discussion with ExCom members:
  - Potential hosting for UNGA event – Venue, high-level participation, announcing a pledge and other forms of support.
  - Any early indication of support to factor in our follow up planning for pledges in 2019.
